What could be nicer than seeing a young foal frolicking in the pasture? It's simply wonderful to behold! Once again, many foals were born this year. The most creative names – all beginning with the letters J, K or L – are being registered. Here are the rules concerning the registration of foals:

RULES FOR THE IDENTIFICATION & REGISTRATION OF FOALS

Important notice for breeders: The rules for I&R are strictly enforced by the KFPS. The basic rules, based on both the EU regulation and the KFPS registration rules, that you have to consider are:

- For proper identification, your Friesian foal must be implanted with a microchip and you must have applied to the KFPS for the foal's passport within 6 months of its birth. If you exceed this deadline, the KFPS is legally obliged to note in the passport that the animal is not suitable for slaughter for human consumption.
- If you also want to register the pedigree, the foal must be at the side of its dam at the time the microchip is implanted.

If you cannot fulfill these conditions, registration of the pedigree can take place only after DNA verification, the costs of which shall be incurred by the owner.

The implanting of a microchip is done at no charge by the KFPS at Stud-book Inspections and local breeding association events.

DNA VERIFICATION

KFPS randomly performs DNA testing to verify lineage. DNA verification is always mandatory in the following situations:

- a. When a mare was bred by/inseminated with two different stallions within one cycle. The cost of the testing is incurred by the registered owner.
- b. When the correctness of the breeding information from which the foal is supposed to have been born is in doubt. The cost of the testing is incurred by the registered owner.
- c. When the breeding date registered with KFPS does not correspond with the birth date of a foal. The cost of the testing is incurred by the registered owner.
- d. When a foal is presented for identification without its dam. The cost of the testing is incurred by the registered owner. A veterinary statement, in which the dam is certified, dated at the most one week after the date of birth, will provide exemption.
- e. When a foal is identified (chipped) by a person other than a KFPS official and the request for registration in the Foal register takes place more than four weeks after chipping. The cost of the testing is incurred by the registered owner.
- f. If the micro transponder cannot be found or is defective. If the transponder was injected by KFPS the cost of DNA testing is to KFPS. If that is not the case the cost is incurred by the registered owner.
- g. Registration of foals born from embryo transfer. The cost of the testing is incurred by the registered owner.

- h. Stallions before they participate in the stallion testing. The cost of the testing is incurred by the registered owner.

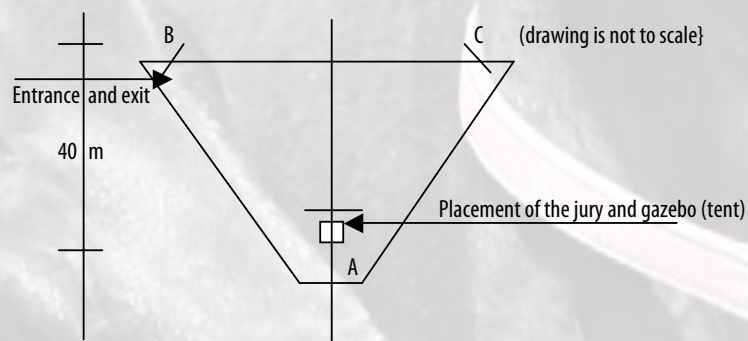

NEW SHAPE OF ARENA 2011

When you are taking your horse to the inspection there will be a new shape for the arena in 2011. This year, the horses will be judged in a triangular arena. This way, the horses will be calmer and will present themselves more naturally, and the judges can see the horse from all sides and can watch how the horse departs.

EXPLANATION OF FOAL INSPECTION FOR THE AWAR- DING OF PREMIUMS

Foals can receive the following premiums at an inspection:

1st premium: 36 or more points

The foals must have earned an average score of 7 for the basic gaits.

2nd premium: 33 through 35.5 points

The foals must not have received any unsatisfactory scores in their scoring column and must have received an average of 6.5 for their basic gaits.

3rd premium: 29 through 32.5 points

If a foal receives one score of 4 or two scores of 5, it will not receive a premium! (In some cases, an exception to this can be made, an example being if the quality of the legs is unsatisfactory.)

The average score for the basic gaits has to be at least 5.5.

This point system is used to display the distribution of the characteristics of the horses being bred. We want to point out that movement is an important part of assessment. It is thus possible for a beautifully developed foal with characteristics very typical of the breed to receive "only" a third premium because its movement is inadequate for receiving a 1st or 2nd premium, or because there were comments made about its legs.

FROZEN SEMEN FROM STUDBOOK STALLIONS

Every year, it's once again a question of selecting the best stallion to breed with your mare. The folder entitled "Fertility" provides information about fertility, stallion selection, veterinary supervision and the pregnancy of your Friesian mare. You can request this folder by sending an e-mail to mail@fps-studbook.com and entering 'Fertility folder' as the subject. To give you more choice of stallions, the stud stations listed here make frozen semen from qualified stallions available.

CENTRAL INSPECTION: SEPTEMBER 16, 17 & 18, 2011 AT THE FRIESCH CONGRES CENTRUM IN DRACHTEN

The Central Inspection is a full-scale event taking up three days this year. The best foals, mares and geldings will be competing for the coveted championship ribbons. Equestrian sports will be featured as well. This weekend, the final competitions will be held for the horses with the best potential for dressage and the best potential for show driving. All in all, a wonderful Friesian horse event that you can see for yourself. Here is a brief impression of the program.

This year, the Central Inspection is being held more than a month earlier than in previous years. This means that we can restore the foal championship to its former glory, the last one being held in 2002. For this competition, the foals should be accompanying their dams and must have acquired a first premium at an earlier inspection or regional judging event. Foals from other countries are very welcome as well. To sign up your foal, go to our site at www.kfps.nl.

Program

Friday, September 16 will focus the spotlight on young horses and equestrian sports. This is the day when the foal championship will be held. The board of the KFPS is making two beautiful decorative plates available as prizes: one for the best filly and one for the best colt. The foal inspection will probably be held outside, just like the inspections for the yearlings and two-year-olds.

This is also the day for the final events in the "Young Friesian Horses with Potential for Dressage" and the "Young Friesian Horses with Potential for Show Driving" competitions. The pre-selection for these events takes place at the regional judging events.

At Friday evening the Friesian Star Sale 2011 will be held. This is an auction of around 50 Friesian horses organized by breeders whose goal is to auction well-qualified horses. A selection committee will select the very best Friesian horses for this auction of fine horses. Also being auctioned will be three-year-old mares that have just participated in ABFP testing. This means that all of their quality characteristics will be available. The auction will be held after the conclusion of the Central Inspection in the FCD exhibition hall. These horses will start being presented at approxima-

tely 5:00 p.m. (the exact time depending on when the Central Inspection concludes), and the auction will begin at 7:00 p.m. For more information: www.friesianstarsale.com.

Saturday, September 17 is the day for inspecting the mares three years of age and older. Star, Crown and Model mares will be judged on this day followed at the end of the day, of course, by paying tribute to the champion. It will be a full day's program that includes certain show events as well.

NEW: Sunday morning, September 18 will be reserved for a foal market organized by the Star Sale Committee. On this morning, the KFPS will be holding a foal inspection for foals that can be purchased at the market. All the foals entered in this inspection will be up for sale. They will be judged in the inspection ring and will then be herded to the market where buyers can come forward. To sign up your foal for this inspection, go to our site at www.kfps.nl.

Deadline for participating in the CI is September 4
Dutch horses can be signed up to participate in the CI through September 4. The last day to sign up horses from other countries that are participating in certain foreign inspections is September 12. These horses will then be added on. Please apply for their participation in the CI by fax or e-mail (see www.kfps.nl) as soon as possible after the inspection.
